RULES & REGULATION

1. International passport for each intending pilgrim is necessary as traveling will be under basic travel quota scheme (B.T.Q.S.).
2. For lady pilgrims "MEHRAM" is compulsory.
3. The tour cost includes, Airfare, Moallim Fees, Lodging & Boarding charges, Bus Charges for Makkah, Madina, Arafat, Muzdalifa, Jeddah and Service Charges.
4. Airport Tax, Qurbani, Coolie Charges and other personal expenses have to be borne by each pilgrim personality.
5. During Haj period all pilgrims are to abide by Saudi Government rules and regulations.
6. No food will be supplied at Mumbai Airport, Jeddah Airport and Muzdalifa by the company; Hence Hajis have to manage themselves.
7. In Arafat light food will be supplied by Moallim.
8. The date of departure will be intimated to each pilgrim 10 days in advance and hence no cancellation of seat(s) will be entertained thereafter.
9. If any increase in Airfare by the Airline, Moallim Fees, Bus Charges, Haj Visa etc. by the Saudi Government, the difference will have to be paid by each pilgrim at the time of departure.
10. The rates of tours were fixed in _____ when the rate of exchange was Rs. _____ to a dollar. Any subsequent increase in the rate of exchange will have to be borne by the Haji accordingly.
11. In any condition company's decision will be final while organising the tours programmes.
12.
